From the CFO's Desk

Revenue from operations for 9M-FY2015 is INR 1,038.69 crores vis-à-vis INR 973.19 crores in 9M-FY2014, representing a 7% increase. The cost of revenue has reduced to 73% (INR 761.75 crores) in 9M-FY2015 from 77% (INR 754.04 crores) in 9M-FY2014. Consequently, the gross margin has improved to 27% in 9M-FY2015 as compared to 23% in 9M-FY2014. Operating EBIDTA stood at 11% in 9M-FY2015 compared to 8% in 9M-FY2014.

Interest cost for 9M-FY2015 stood at INR 164.16 crores compared to INR 252.61 crores in 9M-FY2014.

During the nine months ended 31st December 2014, in line with the approval from CDR, the Company divested its e-Commerce business and product business in UK, at a net loss of INR 287.64 crores.
