Greetings from 3i Infotech Ltd.

It is my privilege to present to you the results of the first quarter of FY2020, a year in which we believe the Company will achieve a paradigm shift. The Company has won its first product order in a decade in the US. Amlock is the product that achieved this breakthrough. In my earlier communications, I had mentioned the investment the Company is making in its Products and Services, one of which is in a state-of-the-art comprehensive, but modular, General Insurance product. I am pleased to inform you that the Company has already won 2 orders for the new product, Premia Astra. Revenue and EBIDTA growth overall has also been healthy. We expect breakthroughs, both in terms of penetration into new regions as well as increase in deal sizes to happen going forward.

The key indices for Q1-FY2020 are as under:

- Core revenue growth of 17% -
 - INR 245.10 crores (USD 35.27 Mn) in Q1-FY2020 vis-a-vis INR 209.21 crores (USD 31.27 Mn) in Q1-FY2019
 - o 12% growth in Products revenue
 - 20% growth in Services revenue
- Core EBIDTA growth of 17% -
 - INR 30.88 crores (USD 4.44 Mn) in Q1-FY2020 vis-a-vis INR 26.29 crores (USD 3.93 Mn) in Q1-FY2019
- Addition of 41 new customers during Q1-FY2020
 - o 20 new customers in Banking, ERP, Financial Services and Insurance products
 - 21 new customers in Services

The market response to our upgraded Products & Services is very encouraging and we intend to step up the momentum to increase our footprints. Additionally, with the increase in maturity of our Services frameworks, we have initiated action on wrapping these frameworks around our Products to significantly increase the value proposition to our customers.
